

13. EXPORT STORAGE CHARGE

Unless by prior arrangement, Swissport Cargo Services reserve the right to charge storage on any cargo received more than 48 hrs before flight departure.

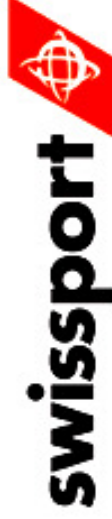
