1.3 IMPORT STORAGE CHARGES

Arrival notification day (NFD) and the following weekday (1) are free of charge. Thereafter the storage fee for the next three (3) days is 0,145 € per kg per day. Minimum charge is 12,00 € per day. Thereafter the storage fee is 0,18 € per kg per day, minimum charge is 18,00 € per day.

Storage fee is addressed to the consignee/party nominated as the agent in the Air Waybill. If the shipment is being transferred to another party, Swissport Finland Oy disclaims any responsibility concerning the allocation of warehouse charges. The charges are based on the chargeable weight of the shipment.
