IVÁN NASH VILA APPOINTED CHIEF FINANCIAL OFFICER

Swissport has appointed Ivan Nash Vila as Chief Financial Officer and member of the Executive Leadership Team. With the appointment and the recent nomination of Christopher Rayner as the company's Chief HR Officer, Swissport completes the renewal of its Executive Leadership Team following its new shareholder structure.

Iván Nash Vila will be joining Swissport International AG as Chief Financial Officer for the group and become a member of the Executive Leadership Team on 1 October 2021. He succeeds Dr. Alexander Gradow, Head of Financial Planning & Analysis, who had been acting as interim Chief Financial Officer since August. Mr. Nash Vila will report to Warwick Brady, President & CEO of Swissport International AG.

"We are pleased to have Iván join Swissport as CFO," said Warwick Brady, President & CEO of Swissport International AG. "Iván has a proven track record in key finance roles, including over 10 years as a CFO and experience from M&A to operational finance. He draws on years of international management experience and, with his background, is ideally equipped for this role and the future development of Swissport."

Mr. Nash Vila previously served as CFO of Endemol Shine Group in Amsterdam, Netherlands until its sale to an industry player. Prior to that he was with Liberty Global plc. in several senior roles, most recently as CFO for Switzerland, Austria and Central and Eastern Europe. In Liberty Global plc (LGI), Mr. Nash Vila also served as Director of Mergers & Acquisitions and Head of Group Financial Planning and Investor Relations Europe. He started at LGI following the sale of Cablecom, Switzerland's largest cable operator where he was Head of Corporate Finance and Investor Relations, to LGI. He holds an MBA from the London Business School and a BBA in Finance from the University of Texas at Austin, USA.

With the appointment of Mr. Nash Vila as Chief Financial Officer, as well as the recent nomination of Christopher Rayner as the company's Chief HR Officer, Swissport has now completed the renewal of its Executive Leadership Team following its new shareholder structure.

"Together with our Regional Business Leaders, we now have a capable and effective senior management team in place to successfully tackle the tasks ahead," adds Warwick Brady. "Our customers will be front and center in our efforts to form the undisputed global market leader and go-to brand for global aviation ground services."

In 2020, Swissport International AG provided best-in-class airport ground services for some 82 million airline passengers (pre-Covid 2019: 265 million) and handled roughly 4.1 million tons of air freight (2019: 4.6 million) at over 100 cargo warehouses worldwide. Several of its warehouses have been certified for pharmaceutical logistics by IATA's CEIV Pharma and by the British MHRA. Swissport is the world's leader in airport ground services and air cargo handling with currently around 43,000 employees and was active at 274 airports in 44 countries on six continents at the end of July 2021.
