If the shipment is being transferred to another party, Swissport Finland Oy disclaims any responsibility concerning the allocation of warehouse charges. The charges are based on the chargeable weight of the shipment.

Deviation fee of 79,00 € per shipment is charged when information described on airwaybill differs from the actual weight and/or measurement of the shipment.
